

TERMS OF USE FOR BUSINESS INFORMATION SYSTEMS WEB SITE

THIS VERSION IN EFFECT SINCE September 1, 2008

THIS AGREEMENT GOVERNS YOUR USE OF THE Business Information Systems WEB SITE AND THE CONTENT, INFORMATION AND SERVICES PROVIDED THROUGH THE WEB SITE. IT EXEMPTS Business Information Systems AND OTHER PERSONS FROM LIABILITY OR LIMITS THEIR LIABILITY AND CONTAINS OTHER IMPORTANT PROVISIONS THAT YOU SHOULD READ.

1. YOUR ACCEPTANCE OF THIS AGREEMENT This is an Agreement between you and all persons you represent (and for purposes of this Agreement, "person" includes natural persons and any type of incorporated or unincorporated entity) and Business Information Systems Inc. ("Business Information Systems"), and governs your use of the Business Information Systems web site and the content, information and services provided through the Business Information Systems web site (collectively the "Web Site"). This Agreement also provides benefits to Business Information Systems' affiliates, service providers, suppliers and sub-contractors, including various Business Information Systems businesses around the world (collectively "Affiliates and Providers"). Each time you use the Web Site you signify your acceptance and agreement, and the acceptance and agreement of all persons you represent, without limitation or qualification, to be bound by this Agreement, and you represent and warrant that you have the legal authority to agree to and accept this Agreement on behalf of yourself and all persons you represent. If you do not agree with each provision of this Agreement, or you are not authorized to agree to and accept this Agreement, you may not use the Web Site.

2. **SCOPE OF THIS AGREEMENT** This Agreement is in addition to and supplements any written agreements that you or any persons you represent have with Business Information Systems or Affiliates and Providers (now or in the future) concerning your dealings with Business Information Systems or Affiliates and Providers generally. Persons using the Web Site must comply with all applicable laws. Business Information Systems may in its discretion refuse permission to access and use the Web Site.

5. **WEB SITE COMMUNICATIONS AND ORDERS** The Web Site is a portal and information conduit to other web sites and businesses operated by Affiliates and Providers. Affiliates and Providers may be independent from Business Information Systems, their web sites may have different or inconsistent terms of use or privacy policies, and their services may be provided under different terms and conditions. Your dealings with Affiliates and Providers and use of their web sites are at your own risk, and you shall not make any claim against Business Information Systems arising out of those matters. As between you and Business Information Systems, the provisions of this Agreement under the section headed Disclaimer, Liability Exclusion, Liability Limitation, Release and Indemnity apply, with all necessary modifications, to your dealings with any Affiliates and Providers and use of their web sites. By activating certain links, including order-related links, you may be automatically connected with web sites operated by Affiliates and Providers. If you use the Web Site to initiate communication regarding your staffing needs, the information you submit may be disclosed to, and processed and responded by, Affiliates and Providers. All communications you submit through the Web Site or email must be true, accurate and complete. Business Information Systems and Affiliates and Providers will rely upon the truth, accuracy and completeness of the communications you submit through the Web Site. If you submit any incorrect or incomplete communications, or if any communications are damaged or distorted during transmission to Business Information Systems, you and all persons you represent will be liable for any loss, damage or additional costs that you, Business Information Systems, Affiliates and Providers, or other persons may incur as a result. You authorize Business Information Systems and Affiliates and Providers to: (a) accept communications that they receive from you by means of the Web Site or email as if those communications had been given directly by you in writing and signed by you; (b) disclose your communications to any Affiliates and Providers, and Business Information Systems workers by means of the Web Site, email or other communications; and (c) respond to your communications by means of Internet communications, email or other communications. Communications you send to Business Information Systems by means of the Web Site or email are not effective unless and until they are processed by the responsible Business Information Systems representative. discretion, and without any notice or liability to you or any other person, including, without limitation, if: (a) Business Information Systems cannot process the communications; (b) the communications violate any provision in this Agreement or any other agreement that you or any other person may have with Business Information Systems; (c) Business Information Systems considers that the communications conflict with any other instructions or agreements with you or any person you represent; or (d) there is an operational failure or malfunction in connection with the transmission of the communications.

6. **ERRORS** Business Information Systems endeavors to provide accurate information through the Web Site. Nevertheless, errors may occur. Accordingly, Business Information Systems reserves the right to change other information available through the Web Site at any time and from time to time without any notice or liability to you or any other person.

13. LINKING, FRAMING, MIRRORING, SCRAPING AND DATA-MINING THE WEB SITE Links to the Web Site without the express written permission of Business Information Systems are strictly prohibited. The framing,

mirroring, scraping or data mining of the Web Site or any of its content in any form and by any method are strictly prohibited.

14. **TERMINATION OF THIS AGREEMENT AND THE WEB SITE** If you breach any provision of this Agreement, you may no longer use the Web Site. Business Information Systems may, at any time and for any reason and in its discretion: (a) change, suspend or terminate, temporarily or permanently, the Web Site or any part of it; or (b) restrict, suspend or terminate (in whole or in part) your permission to access or use the Web Site; all without any notice or liability to you or any other person. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. The arbitration will be before a single arbitrator. The place of arbitration will be Piney Flats, Tennessee, United States of America. Notwithstanding the foregoing, you or Business Information Systems may seek injunctive relief from an appropriate court located in Piney Flats, Tennessee prior to or during the arbitration. Any claim or cause of action you may have arising from, connected with, or relating to your use of the Web Site, this Agreement, or any related matters must be commenced within six (6) months after the claim or cause of action arises, after which time the claim or cause of action is forever barred, regardless of any statute or law to the contrary.

16. **OTHER MATTERS** If any provision of this Agreement is found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed to be severed from the rest of this Agreement and shall not affect the validity and enforceability of any remaining provisions. Notwithstanding anything herein to the contrary, the following provisions of this Agreement, and all other provisions necessary for their interpretation or enforcement, will survive indefinitely after the termination of this Agreement and remain in full force and effect and be binding upon the parties as applicable: 8 (Disclaimer, Liability Exclusion, Liability Limitation, Release, and Indemnity); 9 (Ownership and Permitted Uses of the Web Site); 11 (Personal Information Privacy); 12 (Other Sites); 14 (Termination); 15 (Governing Law and Dispute Resolution); and 16 (Other Matters). The provisions of this Agreement will inure to the benefit of and be binding upon each of Business Information Systems and Affiliates and Providers and each of their respective successors and assigns and related persons, and you and your heirs, executors, administrators, successors, and personal representatives, and all persons you represent and their respective successors, assigns and related persons. You and the persons you represent may not assign this Agreement or the rights and obligations under this Agreement without the express prior written consent of Business Information Systems, which may be withheld in Business Information Systems' discretion. Business Information Systems may assign this Agreement and its rights and obligations under this Agreement without your consent or the consent of any persons you represent. No consent or waiver by any party to or of any breach or default by any other party in its performance of its obligations under this Agreement will be deemed or construed to be a consent to or waiver of a continuing breach or default or any other breach or default of those or any other obligations of

that party. No consent or waiver will be effective unless in writing and signed by all parties. You and any persons you represent (on the one hand) and Business Information Systems and Affiliates and Providers (on the other hand) are independent contractors and no agency, partnership, joint venture, employment or franchise relationship is intended or created by this Agreement or your use of the Web Site. The parties have expressly requested and required that this Agreement and all other related documents be drawn up in the English language. BUSINESS INFORMATION SYSTEMS PRIVACY POLICY

THIS VERSION IN EFFECT SINCE September 1, 2008

Protecting your privacy is important to Business Information Systems ("Business Information Systems"). This Privacy Policy explains how Business Information Systems collects, uses, and discloses the personal information you may provide while using Business Information Systems' Business Information Systems.com web site and the content, information and services provided through the Web site (collectively the "Web Site").

YOUR CONSENT

1. By using the Web Site, you signify your consent to the collection, use, and disclosure of your personal information in accordance with this Policy. If you do not agree with this Policy, you may not use the Web Site.

INFORMATION AUTOMATICALLY COLLECTED

2. Non-Identifiable Information - Like many other Web sites, the Web Site automatically collects certain non-identifiable information regarding Web Site users, such as the Internet Protocol (IP) address of your computer, the IP address of your Internet Service Provider, the date and time you access the Web Site, the Internet address of the Web site from which you linked directly to the Web Site, the operating system you are using, the sections of the Web Site you visit, the Web Site pages accessed and information viewed., and the materials you post to or download from the Web Site. Cookies enhance the convenience and use of the Web Site. For example, the information provided through cookies is used to recognize you as a previous user of the Web Site, to track your activity at the Web Site in order to respond to your needs, to offer personalized Web page content and information for your use, to automatically populate online forms with your personal information for your convenience, and to otherwise facilitate your Web Site experience. Advertisements displayed on the Web Site may also contain cookies or other technologies. Those advertisements may be provided by third party advertising companies, and Business Information Systems does not have any control over, or any responsibility or liability for, the cookies or other technologies used in the advertisements or for the use and disclosure of information collected through advertisement cookies. You may choose to decline cookies if your browser permits, but doing so may affect your use of the Web Site and your ability to access or use certain Web Site features.

PERSONAL INFORMATION YOU SPECIFICALLY PROVIDE

4. Your Personal Information - During your use of the Web Site, you may be asked to voluntarily provide your résumé, curriculum vitae or other personal information (such as your name, email address, postal address, telephone number) and information regarding any Business Information Systems customer or other person you represent, for purposes such as facilitating communications with you, applying for access to certain special features or areas of the Web Site, using Business Information Systems' employment-related

5. (ii) Disclosure to Affiliates - Business Information Systems may provide your personal information to its affiliated businesses for employment-related purposes or for use in connection with matters relating to your use of the Web Site. (v) Law Enforcement and Legal Disclosure - Business Information Systems may disclose your personal information to a government institution that has asserted its lawful authority to obtain the information or where Business Information Systems has reasonable grounds to believe the information could be useful in the investigation of unlawful activity, or to comply with a subpoena or warrant or an order made by a court, person or body with jurisdiction to compel the production of information, or to comply with court rules regarding the production of records and information, or to their legal counsel.

9. Location of Information - Business Information Systems will store and process your personal information in Piney Flats, Tennessee, U.S.A., or, from time to time, in other locations that Business Information Systems decides are necessary or convenient in order to provide you with efficient and effective service.

10. Securing Your Information - To help protect the confidentiality of your personal information, Business Information Systems employs security safeguards appropriate to the sensitivity of the information. Nevertheless, due to the nature of Internet technologies, security and privacy risks cannot be eliminated and Business Information Systems cannot guarantee that your personal information will not be disclosed in ways not otherwise described in this Policy.

11. Accessing Your Personal Information - You may request access to your personal information and information about Business Information Systems' collection, use and disclosure of that information by contacting Business Information Systems at webmaster@nelsontechnology.com. Subject to certain exceptions prescribed by law, you will be given reasonable access to your personal information, and will be entitled to challenge the accuracy and completeness of the information and to have it amended as appropriate. You can help Business Information Systems maintain the accuracy of your information by notifying Business Information Systems of any changes to your personal information.

OTHER MATTERS

12. 13. Former Users - If you stop using the Web Site or your permission to use the Web Site is terminated, Business Information Systems may continue to use and disclose your personal information in accordance with this Policy as amended from time to time.

14. Other Web Sites - The Web Site may contain links to other Web sites or Internet resources. When you click on one of those links you are contacting another Web site or Internet resource that may collect information about you voluntarily or through cookies or other technologies. Business Information Systems has no responsibility, liability for, or control over those other Web sites or Internet resources or their collection, use and disclosure of your personal information. You should review the privacy policies of those other Web sites and Internet resources to understand how they collect and use information.

15. Privacy Policy Changes - This Policy may be changed from time to time in Business Information Systems' sole discretion and without any prior notice or liability to you or any other person. The collection, use and disclosure of your personal information by Business Information Systems will be governed by the version of this Policy in effect at that time. New versions of this Policy will be posted here. Your continued use of the Web Site subsequent to any changes to this Policy will signify that you consent to the collection, use and disclosure of your personal information in accordance with the changed Policy.
